GENERAL PURPOSE

To instruct swim lessons to all program participants with safety being of the utmost importance.

ESSENTIAL DUTIES AND RESPONSIBILITIES

- Meet the attendance requirement of the position, which calls for a work schedule Monday Friday from $8:30 \, \text{am} 11:30 \, \text{pm}$.
- Work closely with the Swim Instructor Supervisor to facilitate the overall program plan.
- Become familiar with various swim levels/curriculum and know how to teach course materials effectively.
- Demonstrate professionalism and patience while meeting the participant's interests, abilities and goals.
- Educate participants on proper technique and promote swimmer safety.
- Conduct swim tests as required.
- Assist with completing skill sheets, lesson logs and attendance information as needed.
- Provide for the health and safety of participants, including ensuring that all teaching and practice areas are free of hazards and that materials and equipment are safe. Maintain cleanliness and safety of pools and equipment.
- Tend to accident or emergency situations in accordance with accident/incident protocols and/or emergency action plans.
- Attend mandatory meetings and trainings as scheduled.
- Complete and submit payroll information weekly.
- Complete additional duties as assigned.

MINIMUM QUALIFICATIONS

Education and Experience:

- (A) High school education preferred, although not required.
- (B) Must have your CPR and First Aid certification prior to the start of the program.
- (D) Must have a thorough knowledge and application of swimming and water safety skills
- (C) **All instructors are required to obtain** the Child Abuse, Criminal History and FBI clearances which can all be applied and paid for electronically at the cost of the applicant.
